

ACTION PLAN 2019

IDENTITY

The **Portuguese Network Smart, Healthy, Age-Friendly Environments** brings together a wide range of Portuguese organizations committed to the promotion of a joint agenda for the implementation of Inclusive Environments for all ages, with particular emphasis in the areas of Health, Social Support, ITCE (Information Technology, Communication and Electronics) and Infrastructures.

The Portuguese Network also favors a quadruple helix participation and actively promotes the collaboration between research/academia, public authorities, companies and civil society /citizens, with the aim of finding common solutions to national challenges in this theme, based on the following principles:

NETWORK PRINCIPLES

1. Governance

The network is promoted by a working group (WG) composed of two main bodies:

Coordination:

- The technical coordination is ensured by Cáritas of Coimbra, in the responsibility of Carina Dantas.
- The scientific coordination will be responsibility of João Apóstolo, professor at the Nursing School of Coimbra (ESEnfC).

Consulting board

The Advisory Board brings together ten high-level experts at national level:

These main bodies assure the Network streamline and are responsible for: i) bringing priorities and real-based challenges; ii) providing guidance on the content that could be explored; iii) guiding potential and relevant stakeholders to the working agenda; iv) planning meetings and events; v) providing articulation between the various network partners; and vi) establishing media and dissemination of relevant information.

2. Participation and funding

The network participation is opened to all interested organizations and does not have any associated cost. The network engagement is formalize through an online submission that ensures the subscription of the Institutional Data Privacy Policy.

The network events are free, and the costs associated to travel or similar need to be ensured by each participant. The realization costs associated with the events are in charge of the host partner or shared between partners by prior agreement. In particular situations, it may be decided by the WG to request support / funding to streamline events (casuistic decision).

3. Communication

The network activities are supported by a website, ensured on the first year of operation by the Cáritas of Coimbra. This website will include the network identity, the WG identification and its partners, the strategic agenda, the spread of relevant activities and good practices.

Communication is privileged, whenever possible, through digital tools, in order to avoid financial constraints and to allow the broadening of participation to all partners.

Regular work events and meetings are essential to implement the network's strategic objectives, foster collaboration among the various partners, allowing to share challenges, explore opportunities, and implement the scheduled agenda.

Events include:

- An initial forum participatory meeting
- Network regular meetings
- External events participation

The Portuguese network integrates the European Connected Health Alliance (ECHAlliance) and is also represented as a Stakeholder's Network in the EU Health Policy Platform (HPP) and the technical coordination ensures this relationship and coordinates it with the other members.



STRATEGIC THEMATIC AREAS AND ACTIVITIES

The Portuguese Network of Smart, Healthy Age-Friendly Environments arises from the need to create a more cohesive and structured organization at national level, based on the European level existing initiatives. Some of these European initiatives are part of this project, but a focus on national needs and policies will be made.

With the aim of creating a joint agenda for the implementation of inclusive environments at all age groups, with specific incidence in the areas of health, social support, ITCE (Information Technology, Communication and Electronics) and infrastructures, the following thematic areas that define the network action plan have emerged after the first participatory meeting:

- 1. Influence on policy and implementation;
- 2. Business models/implementation;
- 3. Collaboration and communication;
- 4. Health and well-being throughout the life course;

Throughout this action plan, the various challenges will be presented, as well as the main actions to be carried out during 2019 for each of the defined themes. Per thematic area and associated activities, there are participants and responsibles in each action, as well as the identification of outputs and results.
